New Business:

Moss Bluff Main Complex Lighting Project: Board recognized David Brossett-Brossett Architects, he presented the Board with the Bid Tabulation sheet for the Moss Bluff Main Complex Lights Replacement Project. Three bids were turned in, with the lowest being from Trahan Construction at \$1,855,000.00. The other bids were from Shannon Smith Construction and Lake Area Electrical. Brossett recommends Trahan Construction be awarded the contract for the Moss Bluff Main Complex Lights Replacement Project. Brossett has reached out to Trahan Construction, and they are working on their 10-day documents. David asked if Trahan indicated what light system they would be going with. Brossett stated they have not at this time but should know about seven to ten days. He added that the bid was detailed with very specifically about what lighting the Park wanted. David asked Richard if we know what the Park has gained so far from Insurance in reference to the lighting. Richard stated no, we do not have that amount. David stated he feels the Board needs to move forward with the Lighting Project. He understands the uncertainties about the Insurance claims and FEMA but feels its in our best interests to move forward. Bill agrees with David, the Park has funds for the Lighting Project, and we need to move forward. Bill asked if we had a timeline of the project. Brossett stated they estimated the project at 180 days from getting notice to proceed. Bill asked if Trahan Construction stated anything about material or labor delays. Brossett stated they did not.

David Nixon made motion to accept the bid from Trahan Construction for the Moss Bluff Main Complex Lighting Project for \$1,855,000.00: Second by Bill Willis. All in Favor. Motion Passed.

Millage Tax Renewal Election: Board reviewed last years, year to date report. Connie asked what is needed to be done before the election. Bill would like to reach out the leagues to explain to them the different projects that are about to start such as the lighting and fencing projects. He would like to give them a vision of where we would like to park to be in the future. David agrees reaching out to the leagues to discuss current projects and future projects would be beneficial. Connie stated we also need to engage the Seniors with the upcoming election. Richard stated he is going to take photos around the park to show the parks progress. The Board would like to see about doing a mail out to the community like what we had done in the past election.
